

Privacy and cookies policy

1. GENERAL PROVISIONS

1.1 The Site www.timesd.com, including <https://timesd.azurewebsites.net> and <https://timesd120.azurewebsites.net>, is managed by Enedig Project Management Kft. (Company), a Hungariann limited liability company having its headquarters located in 1154 Budapest, Szerencs street 172, registered with the Trade Registry with no. 01-09-414400, Registration Code HU32252952, e-mail address: office@enedig.hu.

1.2 Site and/or Software and/or timesd.com represents the online website belonging to Company at the following web address www.timesd.com (and the above specified inclusions) through which the Visitor (Visitor: Software User and Site Visitor) has access to information, services and software use offered by Company through the website www.timesd.com and its connected domains.

1.3. This Privacy and Cookies Policy is part of the Terms of Use available at www.timesd.com and in the running software section under the name „Terms of Use”.

1.4 Company reserves the right to amend this Privacy and Cookies Policy from time to time. Any amendments that will be brought to this Privacy and Cookies Policy will enter into force immediately at the time when they are posted on the Site. We will inform the Visitors of the respective change on the Site or, if possible, via email. Notwithstanding the aforementioned, in case the Visitor continues to use the Site, after any changes have been made to the Privacy and Cookies Policy, it will be considered that the Visitor has agreed with the performed changes.

1.5 Please note that by accessing and using our Site, you consent unconditionally to our Privacy and Cookies Policy and Terms of Use.

1.6 In case a Visitor disagrees with any of the terms and conditions of this Privacy and Cookies Policy and the Terms of Use, the Visitor cannot use the software and is advised to discontinue the use of the Site.

1.7 We strive to ensure the protection of your privacy when using our services. Therefore, we have a policy to determine how your personal data will be processed and protected.

2. PERSONAL DATA COLLECTED

2.1 Personal Data will be collected and processed by timesd.com site and software based on the express and unambiguous consent granted by the Visitor on the basis of a separate declaration of consent (in connection with the registration to the Site and Software) and through the acceptance of the Terms of Use available both at www.timesd.com and in the running software section and this Privacy and Cookies Policy.

2.2 The Visitor's Personal Data will be processed by timesd.com in accordance with the Hungarian laws in force.

2.3 WHAT TYPES OF PERSONAL DATA WE COLLECT AND HOW WE USE?

We will collect the personal data you transmit to us when, for example, you register, log in or contact our customer support / support department or our services. Your personal data may include, for example, contact information, the profession, workplace and payment information, and we can also collect some personal data from external sources, such as information on solvency, and address updates.

2.4 timesd.com collects and processes the Visitors' Personal Data for the following purposes:

- to open, manage and use the Visitor' Accounts on the Site;
- to track the Visitor's activity during the software use;
- to send software alerts;
- to contact you in case of any problems with using the software;
- to respond to your requests and to inform you about new or modified services;
- to send regular electronic newsletters and/or alerts;
- to perform analyzes to provide you with marketing offers and relevant information;
- to validate, send and invoice the Visitor's Orders;
- to send you questionnaires giving you the opportunity to influence our offer and services;
- to test, customize and improve our systems and content with which we provide our services;
- to prevent misuse or inappropriate use of our services;
- to comply with statutory, legal and regulatory obligations;
- for statistical purposes;
- to send the data to timesd.com e-mail dispatch service for enabling correspondence through e-mails;

- to send the data to the mailing service;

2.5 timesd.com does not request and does not have access to your bank account details.

2.6 The Visitor does not have to provide any of the Personal Data requested. However, failure to indicate any of such data may prevent timesd.com from performing, in whole or in part, any of its Services or obligations provided on the Site and/or the Visitor will not be able to use the Site properly.

2.7 The Visitors' Personal Data will be processed only for legally justified objectives pursued by timesd.com, including sending commercial information, for example by means of the newsletters to the Visitors. The number of newsletters sent by timesd.com may vary. At any time, the Visitor shall have the right to request a discontinuation of receiving such information/offers by clicking on the unsubscribe link provided at the bottom of each newsletter or by changing Visitor's settings on the website.

2.8 We will keep your data as long as necessary to meet the above purposes or as required by law. Your personal data will then be deleted.

2.9 WHAT ARE YOUR RIGHTS?

You have the right to request information about personal data we hold about you (free of charge once a year). If your data is incorrect, incomplete or irrelevant, you may request that this information be corrected or removed. We cannot remove your data when there is a contractual requirement between us and your employer or a legal requirement to keep them, such as accounting rules, or when there are other legal grounds for storing data such as unpaid debts. You may withdraw your consent to the use of our data for marketing purposes. 2.10 WHO HAVE ACCESS TO YOUR PERSONAL DATA? HOW DATA ARE PROTECTED?

We do not transmit, sell or give your data to third parties for marketing purposes. Data that is transferred to third parties is used only to provide you with the services mentioned above, for example to other companies in our group, to agents and service providers, if we sell our business or in cases where we are legally required to transmit information Or if we consider that action is needed for fraud, cybercrime or to protect the site, rights, personal safety. We may also disclose aggregate statistics about our site visitors to describe our services to potential partners (advertisers, sponsors) and other reputable third parties for other legal purposes, but these statistics will not contain personally identifiable information.

2.11 We have taken technical and organizational measures to protect your data against unauthorized loss, manipulation or unauthorized access. We continuously adapt our security measures in line with technological progress and developments.

2.12 All details related to any form of electronic payments on the Site are taken and processed directly and encrypted, complying with international security standards, by the payment processor, and we do not have at any time your data.

3. COOKIES

3.1 A cookie is a small text file that is saved on your computer or mobile device and is recovered from it during your subsequent visits. We use the cookies to make the visit to our site simplified and streamlined. There are two types of cookies: persistent and temporary (session cookies). Persistent files are stored as a file on your computer or mobile device. Session cookies are temporarily stored and disappear when you close the browser session.

You can easily delete cookies from your computer or mobile device in your browser.

3.2 Any Personal Data collected and stored through use of Cookies is first obtained through notice and consent by providing the Visitor with transparent notice of use of Cookies and with the opportunity to make a choice to disable such Cookies.

3.3 Most of the Cookies used by timesd.com are deleted from the Visitor's hard disk drive ("Session Cookies") at the end of the Visitor's session. Other cookies remain on the Visitor's computer to help to identify it during the next visit ("Persistent Cookies"). You are free to block, delete, or disable these technologies if your device allows this. Visitors can manage their cookies and cookie preferences in their browser or device settings. It generally does not prevent the use of the Site, but it may cause some difficulties in its operation.

3.4 Given the fact that the market of monitoring services is growing rapidly, timesd.com is trying to inform the Visitors about the use of services provided by new entities in this respect, and the Visitor agrees to the provision of such services in the future also by other companies. At the same time, timesd.com informs that the Visitor may at any time revoke his/her consent in this regard, by changing the settings of his/her web browser, in accordance with the procedure set out below.



3.5 Our cookies do not store sensitive information such as your name, address or payment details: they only hold a reference that is linked with the way you use our site. Here is a list of all the cookies we use, and what we use them for.

Essential cookies – These cookies enable you to use the software at timesd.com. Without these cookies, you would be unable to shop at timesd.com, to sign in to your account and to use the software on the site. If you would prefer not to accept these cookies, you can change your browser settings to do this.

Analytics cookies – These cookies are used to monitor the performance of the site by using anonymized data (i.e. not traceable to any particular person) of how our site is used, what links people click on, etc.

Payment cookies – When card payment will be available: These cookies are used by our payment partner for payments with credit card.

Social cookies – These cookies are set by the social networks (Facebook, Twitter, Google+, YouTube, etc) and allow you to share content from timesd.com with your friends on social networks. We do not control the setting of these cookies, so we suggest you check the third-party websites for more information about their cookies and how to manage them.

3.6 timesd.com uses different systems offered by third parties to monitor the Visitor's on-line activity, such as Google Analytics, the so-called web analysis service offered by Google Inc. Google Analytics uses cookies, i.e. text files placed on the Visitor's computer enabling an analysis of how the Site is used. timesd.com also uses standard web server log files to count persons visiting the Site, to track the software used and to assess its technical capabilities. timesd.com uses this information to determine how many people visit the Site and to provide from the software the Visitor activity-based statistics to the Visitor's employer company. By deciding to use the articles/services offered by timesd.com, the Visitor acknowledges the foregoing activities and agrees to them.

3.7 The information on the use of the Site by the Visitor generated by cookies (including his/her IP address) is transmitted, for example, to a server of Google Inc. located in the U.S.A. and stored in accordance with Google's privacy policy (available at: <http://www.google.com/intl/pl/privacy/privacy-policy.html>). Google uses this information to evaluate the use of the Site, to create reports for website operators concerning the activity on the website and to provide other services related to the use of the Site and the Internet.

4. INFORMATION NOTE FOR THE PROTECTION OF PERSONAL DATA

4.1 According to the requirements of the Hungarian Laws on the protection of individuals with regard to the processing of personal data and on the free movement of such data, Enedig Project Management Kft. a Hungarian limited liability company having its headquarters located in 1154 Budapest, Szerencs street 172, registered with the Trade Registry with no. 01-09-414400, Registration Code HU32252952, e-mail address: office@enedig.hu , as controller, bears the obligation to manage under safety conditions and only for the specified purposes the personal data that you provide about yourself or another person.

4.2 The purpose of data collection consists of: login to the Site, sell services, buy services, Visitor activity related statistics to its employer company, marketing, and promotion.

4.3 You must provide the mentioned data, as they are necessary for the conclusion and execution of Transactions, use the software and marketing purposes. Your refusal shall have as a result the incapacity of timesd.com to perform its Services properly and you can't use the software.

4.4 The recorded data are meant for use by the controller and are communicated only to the following recipients: payment service provider , other companies in the group, company's accountants and User's employer company.

4.5 According to Hungarian Laws you have the right to access, to intervene over the data, the right not to be subject to an individual decision and the right to address yourself to justice. You have the right to oppose yourself to the processing of personal data that concern you and to request the delete of such data. In order to exercise these rights, you may address a written request, dated and signed, to Enedig Project Management Kft. a Hungarian limited liability company having its headquarters located in 1154 Budapest, Szerencs street 172, registered with the Trade Registry with no. 01-09-414400, Registration Code HU32252952, e-mail address: office@enedig.hu. You also have the right to address to justice. If any of your data about yourselves are incorrect, we kindly ask you to inform us as soon as possible.

I further grant my express, unambiguous, specific and informed consent to the transfer of my personal data (specified in the registration form or at the purchase of services) by Enedig Project Management Kft. to personal data controllers and/or personal data processors located in EU. I am aware that failure to provide personal data may significantly hinder or prevent the proper operation of the www.timesd.com software as service platform.
